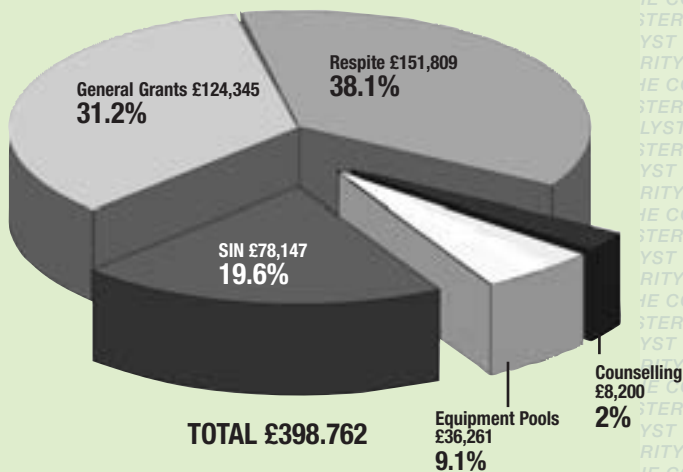

Chairman's Statement

FOR THE YEAR ENDED 30 SEPTEMBER 2009

The investment climate to which I referred last year grew even more stormy in the year to 30th September 2009, with an inevitable impact upon investment values. Nevertheless, despite this and a cautious reduction of £40,000 in the valuation of the freehold property, we ended the year with an increase of over £420,000 in the value of our investments. Income was reduced by 2.3%, but your directors endeavoured to play their full part in improving healthcare for the people of North Essex.

We continued to encourage applications for support, and made grants of nearly £400,000, details of which appear elsewhere in this Report.

I find it interesting to have witnessed the changes in the nature of grants made over the nineteen years since the Charity became a grant making trust. In its early years, many of the grants were devoted to supporting new initiatives and expansion of services provided by caring charities, many of which were local in context and largely voluntary in operation. The provision of transport to day centres and allied activities was a major need. While we continue to receive applications of this nature, and endeavour to help whenever circumstances allow, we have seen a growth in the area of statutory funding for caring activities having a significant impact on the sector, and as is well known, we cannot undertake, replace, or supplement, core funding however sympathetic we are to the needs of the potential beneficiaries.

The provision of respite care and for the special needs of individuals continue to be central to our activity, but we are also able to promote what we consider to be exciting initiatives in research and in the development of treatment which we believe will bring great benefit to the people of our area of benefit, whose interests we serve.

We are concerned too about the need to improve the partnership between local and voluntary care providers and their statutory funders. During the year we began a process which I hope will bring about a greater mutual understanding, and safeguard the provision of care by those with the unique features that local knowledge makes possible.

We were pleased to welcome Christine Kirvan as Chief Executive with effect from January 2009, since when she has taken great strides towards a full understanding of our operation, and has become well known to many of our partner organisations. She is applying her lively mind to means by which the Charity may continue to recognise and meet the changing needs of the future. She, and our Administrator, Stephanie Grant constitute a strong team in whom your directors have great confidence.

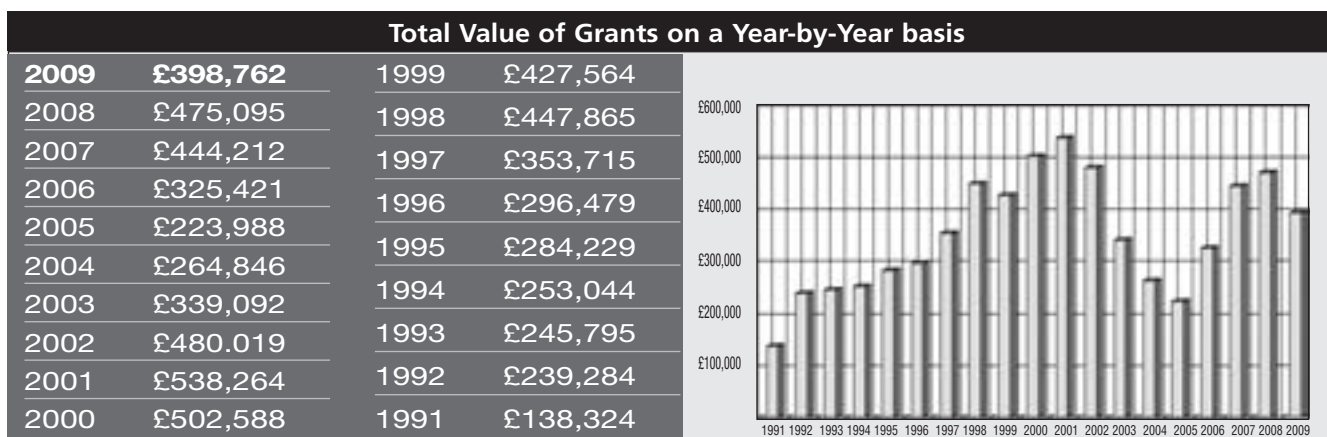
We were very pleased to welcome Mark Pertwee as a director with effect from July. He brings useful experience of business and management in addition to his interest in the community.

I am happy to have this opportunity to express my gratitude to my colleague directors for their unstinting support to the activities of the Charity, and for the knowledge and wise counsel they bring to our discussions.

Finally, I should mention that I intend to retire from the Board with effect from the Annual General Meeting. I have thoroughly enjoyed the privilege of serving as a director both before and since the transformation of the Charity's activities. During my term in the Chair I have been very ably supported, first by Bart Walsh and more recently by Chris Kirvan, and throughout by Stephanie Grant, for which I have been constantly grateful. I am delighted to say that Christine Hayward has agreed to accept the directors' invitation to serve as the next Chairman. With the greatest confidence, I offer her my congratulations, and good wishes for her term of office as Chairman of this important Charity.

Chief Executive's Report

FOR THE YEAR ENDED 30 SEPTEMBER 2009

This is my first Chief Executive's Report for Catalyst, as I started in post in January 2009. I would like to take this opportunity to thank all the people and organisations who have welcomed me into this role, with particular thanks to Stephanie Grant who had stepped into the breach since Bart Walsh retired the previous year. Bart had been at the forefront of Catalyst's activities for many years and is clearly a hard act to follow but I am finding the challenge of this new job extremely interesting, and feel I have made considerable progress with understanding Catalyst's unique activities and becoming fully involved with all our partner organisations.

General Applications

During the year, the Catalyst Trustees considered 34 General Applications from various organisations in our area of operation, of which 21 (62%) were successful. We tried to encourage more innovative applications, and indeed did attract some new types of applications. The 2008-09 budget of £125,000 was almost completely spent.

The largest grants were given for our most innovative projects concerning research. A partnership between the University of Essex and Colchester Hospital NHS Foundation Trust now has a Colchester Catalyst Doctoral Scholar concentrating on state of the art research into prostate cancer. They have been awarded £84,000 over 3 years, just over £27,000 coming from our 2008-09 budget. This is obviously a very exciting project to be facilitating and could have enormously beneficial consequences. Our other research project is supporting St Helena Hospice with a study of specialist end of life care for people with dementia. It is vital that patients are able to live their life with dignity through all stages of

their disease, the Hospice was awarded £26,000 over two years to carry out this research.

A further new idea has resulted in support for The Stockwell Centre to provide Counselling for Carers. Catalyst is providing £5,000 for this pilot project which aims to provide special support for carers. Providing full time care can be stressful, but it has been recognised that a limited number of carers find their task overwhelming, perhaps because of their own mental or physical illness. This project will assist them in coping.

North East Essex Wheelchair Service realised that patients who had suffered a severe stroke need speedy provision of the correct



specialist equipment in order to maximise the benefits of immediate rehabilitation work. Patients were having their discharge delayed or having to be sent home to stay in bed whilst waiting. They suggested an equipment loan pool of 8 tilt and recline wheelchairs which could be customised quickly, enabling 6-8 patients per month to use this service. The Catalyst Trustees agreed and granted £8,640 to provide the necessary equipment. As always, we are delighted to be working in such close partnership with the Wheelchair Service.

The Speech and Language Therapy Team, located in the Independent Living Centre provide a specialist assessment service for those with impaired communication. They needed to be able to select and trial the correct devices for patients prior to making statutory applications for funding. Catalyst agreed to provide £25,000 to help them set up a loan pool of equipment which would assist in improving quality of life and opportunities for their patients.

Special Individual Needs (SIN)

SIN grants continued to increase in number. There were 287 applications with 252 successful, a record number of grants awarded. Once again the vast majority of grants provided mobility equipment for those who could not obtain it from statutory providers. During the year we started to bulk purchase a variety of 3 and 4 wheeled walkers, which saved costs. We then worked in partnership with the Neuro Rehabilitation Unit at Colchester General Hospital to distribute them as necessary.

The SIN Committee is chaired by Adrian Livesley, one of Catalyst's Directors. I am very grateful to the whole committee for making time to assess the many applications we

receive, and to Stephanie for her administration which ensures that the scheme operates so successfully. We regularly receive letters and cards of thanks from individuals and their carers who are so grateful for the help provided – our SIN scheme clearly conforms with Catalyst’s criteria of using our funds to help relieve the sick and suffering in North-East Essex.

Short Term Respite Care

Catalyst provided almost £152,000 to arrange short term respite care, allowing full-time carers to have a break themselves. We work in partnership with about a dozen care organisations, listed on the inside front cover of this report. Our partners are trained as assessors, and each organisation has an agreed annual budget. We monitor the activity and meet together as a group twice each year.

Update

Our regular newsletter, Update, was produced in Spring and Autumn, providing the opportunity to publicise information about our grants, opportunities for making applications and to celebrate the achievements of our partners and clients. We are in the process of gradually updating our

image with a new logo and exciting plans next year for a new website. Watch this space!

Catalyst Forum

During the year we became aware of the financial difficulties being experienced by some of the smaller organisations we deal with. After discussions with the Colchester and

Tending Councils for Voluntary Organisations, we planned a Forum to bring together the statutory organisations and our partner charities to debate the issues of concern. The Forum actually took place in October, just after the end of our financial year and was well attended. We will be following up the concerns discussed in the future.

I would like to take this opportunity to thank all my colleagues, Catalyst’s Chairman and Board, Administrator and our partner charities and organisations for all their help, support and encouragement during this, my first year as Chief Executive. Catalyst is a unique charity, it is such a privilege to be involved. Since Catalyst was established in 1990, almost £6.8m has been given in grants– which brings me to the exciting reminder that this was the charity’s 19th year of operation and we will be celebrating 20 years later this year.

Report of the Trustees

YOUR TRUSTEES PRESENT THEIR REPORT AND FINANCIAL STATEMENTS FOR THE YEAR ENDED 30TH SEPTEMBER 2009.

Constitution and Origins

The company is limited by guarantee (Number 634588), governed by a Memorandum and Articles of Association and is a Registered Charity (Number 228352).

At 30th September 2009 there were 38 members.

Registered Office: Catalyst House, Newcomen Way, Colchester CO4 9YR

Colchester Catalyst Charity became a grant making charity in 1990 following the sale of the Colchester Oaks Hospital, in Oaks Drive, to Community Hospitals PLC. The sale was conditional on Community building a new hospital, to an agreed high specification, by 1994 - this was done and the new Oaks Hospital off Mile End Road was opened in January 1994.

With the agreement of the Charity Commissioners the directors decided to devote the income, from the invested funds resulting from the sale 'for the relief of the sick or suffering of North East Essex'.

Appointment, Induction and Training of New Trustees

Nominations for the appointment of new Trustees are made based on the established knowledge and experience of the candidate and on the likely contribution that the candidate may make to the work of the charity. All Trustee appointments are subject to election at an AGM and all Trustees are subject to re-election at an AGM every three years.

Trustees are provided with appropriate information and guidance on induction; no other formal training is provided to trustees.

Objects and Activities

The objective of the charity is the relief of the sick or suffering of North East Essex. The Trustees confirm that they have referred to the guidance contained in the Charity Commissions general guidance on public benefit when planning its future activities and setting the grant making policy for the year.

Details of the charities activities and achievements during the year are set out in the Chief Executive's Report.

Grant Making Policy

The Charity's detailed grant making criteria are set out elsewhere in this report. All applications for grants are considered by Trustees and are formally approved. An annual grants budget is set by the Trustees.

Investment Policy

The investment policy is determined by the Trustees, with the benefit of external advice, after considering income requirements, risk profile and stock market prospects in the short and medium term.

Reserves Policy

The Trustees have adopted a policy of endeavouring to

► retain sufficient funds to maintain the Capital Reserve as at 30th September 1989 adjusted for inflation. The Capital Reserve as at 30th September 2009 required by this policy amounted to £8965041 (2008 £9082192). It is intended that this policy will be adhered to for the foreseeable future whilst recognising that there may be temporary shortfalls in consequence of fluctuations in stock market values.

Risk Statement

The Trustees confirm that the major risks to which the charity is exposed, as identified by the Trustees, have been reviewed and systems have been established to mitigate these risks.

The Trustees plan for the foreseeable future to continue making grants with a view to making a positive contribution to improving care of the sick or suffering of North East Essex.

INDEPENDENT AUDITORS REPORT TO THE MEMBERS OF COLCHESTER CATALYST CHARITY

We have audited the financial statements of Colchester Catalyst Charity for the year ended 30 September 2009 which comprise the Statement of Financial Activities, Income and Expenditure Account, the Balance Sheet and the related notes. These financial statements have been properly prepared under the historical cost convention as modified by the revaluation of certain fixed assets and the accounting policies set out therein.

This report is made solely to the Company's members, as a body, in accordance with sections 495 & 496 of the Companies Act 2006. Our audit work has been undertaken so that we might state to the Company's members those matters we are required to state to them in an auditor's report and for no other purpose. Notes to the Financial Statements

FOR YEAR ENDED 30TH SEPTEMBER 2009

1 Accounting Policies

Basis of Accounting

The financial statements have been prepared under the historical cost convention, as modified by the inclusion of fixed asset investments at market value, and in accordance with the provisions of the Companies Act 2006, the Statement of Recommended Practice (SORP) Accounting for Charities March 2005 and applicable accounting standards.

Exemption has been taken from preparing a cash flow statement on the grounds that the Company qualifies as a small company.

Income

Donations are accounted for when received by the Charity. Other income including income tax recoverable is accounted for on an accruals basis as far as it is prudent to do so.

Tangible Fixed Assets

The tangible fixed assets are stated in the Balance Sheet at costs less aggregate depreciation written off to date. Freehold properties held as investments are stated at market value.

Quoted Investments

Quoted investments are included at quoted saleable value as at the close of business on the balance sheet date, any surplus or deficit arising on such valuation is carried to capital fund.

Grants and Donations Payable

Grants and donations payable are recognised as expenditure when the grant is approved.

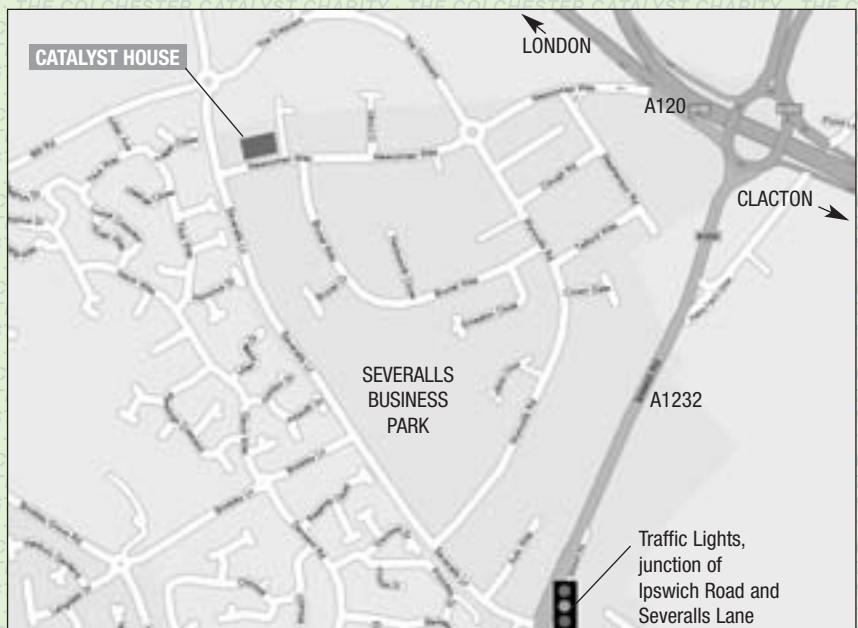
HOW TO FIND CATALYST HOUSE

Criteria for Grant Making

Object

COLCHESTER CATALYST CHARITY

aims to help relieve the sick and suffering by making a positive and ongoing contribution to the improvement of health care within the community of North-East Essex specifically where help is not available from statutory organisations.

Policy

The over-riding concern of the Charity is to provide support where it will benefit the greatest number of people, principally by direct contributions to organisations for specific and well defined projects including therapeutic aids, equipment and buildings for medical or nursing care.

The Charity recognises the need of some disabled people for specialised equipment. Where it is established that such equipment is not available from statutory organisations a contribution may be made to the cost involved.

General funding or contributions to staff or other running costs are excluded but recognising the often overlooked needs of carers the Charity will consider funding respite care provided the care period is well defined, carefully controlled and readily monitored.

Where financial help is given the Directors will satisfy themselves that satisfactory management and organisation exists to ensure that the money is properly used and in the case of equipment, that it can be efficiently operated and maintained.

Support

In appropriate cases a grant or loan may be offered for full or part-funding of a project or equipment.

No form of retrospective funding can be considered.
